Release and Waiver of Liability, Assumption of Risk and Indemnity and Parental Consent Agreement

1. I realize and acknowledge that the Finger Lakes bicycle tour requires physical conditioning and I represent that I am in sound medical condition. I have no physical or mental condition that would endanger myself or others.

2. I understand that bicycling can be a hazardous activity that has many dangers and risks, including injury, permanent paralysis or death resulting from accident or physical exertion. I understand that bicycling involves a risk of injury, that injuries are common and an ordinary occurrence of the sport and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist.

3. I accept responsibility for the condition of my bicycle and agree to abide by all rules of the tour, especially the wearing of a helmet at all times while bicycling on the tour.

4. I agree, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, as a consideration of, and in consideration for, being permitted to participate in the tour, to freely and expressly assume and except any and all risks, known and unknown, of injury or death to the rider, or property loss or damage, including injury, death, or loss or damage attributable to the negligence of In Motion Events their officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event.

5. I agree to release the sponsors and promoters of the tour, including In Motion Events and their respective agents, directors, officers, and employees from any and all responsibility or liability for injury or damages, which result, either directly or otherwise, from my participation in the tour. I agree not to make a claim against or sue In Motion Events or other sponsors or affiliated organizations for injuries or damages related to bicycling and/or other activities during the tour.

6. I am aware that this is a release of liability and a contract between In Motion Events and myself. I am signing it freely and of my own accord and I recognize and agree that it is binding upon myself, my heirs and assigns, and in the event that I am signing it on behalf of any minors, I have the full legal authority to do so, and realize the binding effect of this contract on them, as well as on myself.

7. I agree to In Motion Events using photographs or videos of me for promotional purposes.

8. New Mexico's Ride take us from an elevation of 5,000-8,500 feet. You must be prepared and understand altitude sickness, it's symptoms and have the ability to take precautions.

I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.
